

 - HEAT TREAT: AUSTEMPERED TO 84.0-86.0 HR15N (HRC 46-52).
 - 3. FINISH: CADMIUM PLATE PER AMS-QQ-P-416, TYPE II, CLASS 2. THREADS SHALL SHOW COMPLETE COVERAGE BUT THICKNESS REQUIREMENT IS WAIVED.

COLOR CODE PER TABLE 1. PAINT SHALL NOT BE TOXIC OR CORROSIVE AND SHALL REMAIN PERMANENTLY, PARTS SHALL BE COVERED SUFFICIENTLY TO DISCERN PART SIZE.

- LUBRICATION: SOLID FILM LUBE AS5272, TYPE I, IN ACCORDANCE WITH QPL IN AS5272SUP.
- PROCUREMENT PER BPS-N-70, CLASS 80TA4, EXCEPT AS NOTED. ACCEPTANCE REQUIREMENTS PER BACN10XP.
- TO CALCULATE CORNER HOLE LOCATION SUBTRACT (Y-X)/2 = "A" DIM. OR LESS.
- LOCKING TORQUE PER BPS-N-70 FOR 5 REUSABILITY CYCLES ONLY. MAXIMUM LOCKING TORQUE SHALL BE 5 IN/LBS ON INSTALLATION AND REMOVAL. BREAKAWAY TORQUE SHALL BE 1.0 IN/LBS MINIMUM ON FIRST CYCLE AND 0.5 IN/LBS MINIMUM ON REMAINING CYCLES.
- LOCKING FEATURE SHALL NOT DAMAGE NUT OR BOLT THREADS WHEN TORQUE TESTED.
- DIMENSIONS APPLY AFTER FINISH.
